RATE RECOMMENDATIONS

- 2-3 applications, 7-10 days apart
- · For best performance, tank mix or rotate with compatible products
- · Best control will be achieved with full coverage of all leaf surfaces
- Surfactant may be added to improve product performance
- · Can be applied as a drench to soil or soilless media, avoid excessive leaching
- · Outdoor crops, vegetables and ornamentals: 8-10 oz/acre and 15 oz/ acre for nematode control, 22.5 oz/acre for extremely high pest pressure or dense plant canopy
- · Greenhouse, shade house, interiorscape and nursery crops: 8-10 oz/100 gal
